

CUSTOMER FEEDBACK SURVEY - MONTHLY GIFT CERTIFICATE DRAW RULES & REGULATIONS

The draw is open to all legal residents of Canada who are over the age of majority in their respective province. 1. HOW TO ENTER:

To enter the sweepstakes, complete the customer experience survey through the provided web link. Each successful survey submission will count as one (1) entry into the monthly draw. Only one entry is allowed per day but multiple entries per person are allowed by submitting additional survey responses to reflect subsequent shopping experiences that month.

2. ELIGIBILITY:

This sweepstakes is open to residents of British Columbia, Alberta, Saskatchewan, and Manitoba who are over the age of majority in their province. Employees of Nutters Everyday Naturals, its affiliates, subsidiaries, and their immediate families are not eligible to participate.
